The Company will provide the Customer with a single user login to the Bluewave SWIFT system, which will enable the user to access the Product within Bluewave.SWIFT. The Customer will also have limited access to other relevant aspects of the SWIFT system for ongoing self-evaluation.

Should the Customer, within twelve months of the Activation date, purchase a licence for the complete Bluewave.SWIFT system the Company will credit the Customer with £75 against their first year licence payment.

7. LIMITATION OF USE

Under the terms of this licence the Customer is able to purchase additional products via the Template Market within the Bluewave.SWIFT system. Not all of the products may will be fully functional under this licence and the Customer is advised to check with Bluewave International Ltd before purchasing additional products.
